STATED Meeting of Presbytery

Friday & Saturday, September 24-25, 2021

Hybrid: IN PERSON at Star Valley United Church in Thayne and ZOOM Meeting

FRIDAY

The meeting was called to order by Presbytery Moderator, Rev. Diana Hartman at 1:00 PM. There were 17 in person attendees (14 voting members) and 26 Zoom attendees (19 voting members). Rev. Tammy Heimgartner, from the host Star Valley United Church, led worship.

Synod Report Rev. Bob Garrard (HR) is moderator of Synod and reported the budget for the Synod for 2022 has been approved and there will be a rebate for per capita.

Council Report: Council moderator, Rev. Bob Thomson called attention to the written report of Council that showed the actions taken by Council on behalf of Presbytery since the April 2021 meeting. The highlight was the hiring of Rev. Monica Hall as Interim General Presbyter. Council action items approved by Presbytery:

- 1. Raised the Presbytery per capita portion by \$0.02 to \$33.02, making total \$45.00
- 2. Approved the 2022 Presbytery Administrative and Mission budgets

- 3. Elected Rev. Monte Reichenberg and Melinda Brazzale to the Committee on Representation and Nominations
- 4. Approved revision of policy on reimbursement of expenses for presbytery meetings.

Presbytery will reimburse the following expenses:

Presbytery Meetings

Round trip mileage (at 14 cents per mile) and meals for commissioners and minister members, and for *ruling elder members of council, presbytery committee moderators, and* the moderator (or vice moderator) of Presbyterian Women in the Presbytery of Wyoming.

Round trip mileage, housing and meal expenses for ruling elder officers (presbytery moderator, presbytery vice moderator, stated clerk, treasurer) of the presbytery.

Churches should be reminded to consider including in their budgets provision for covering all non-reimbursed expenses for commissioners and other ruling elder voting members of presbytery.

5. Approved an Administrative Commission to work with the Shoshoni Church on its future and in its agreement with the Wind River Church to use the facilities.

COM Report COM Moderator, Rev. Lynn Williamson, called attention to the COM written report. COM will be working with the Stated Clerk on following up with clergy who have not completed their sexual misconduct policy

requirements and they are also working on the next boundary training. COM had 1 action item approved by Presbytery: Chuck Cooper approved to be session moderator for Riverton Church.

ECLD Report: Rev. Bruce McBurney gave the report that included a presentation on the Red Clay Abbey by Jessika Girod. This is a New Worshipping Community connected to The Table that will be moving into the St. John building, formerly Winter Memorial Church in Casper. ECLD also continued a presentation begun at the September 2020 meeting about becoming missional. This was part 3 of a lecture series given by Michael Frost of the Tinsley Institute, a mission study center in Australia. ECLD presented 2 action items that Presbytery approved:

- 1. The paid position in the presbytery of Campus Minister.
- 2. A search committee to hire the Campus Minister.

New Worshipping Communities (NWC) Report

Pine Ridge Ministries (PRM) report was given by Rev. Shayla Graham. Pine Ridge Ministries celebrated its 5th anniversary this year. Shayla expressed her gratitude to Presbytery for their support.

The Table report was given by Rev. Libby Tedder-Hugus. The Table celebrated its 7th anniversary this year. Libby shared stories of the people who have received the love of God at The Table.

Stated Clerk Report Rev. Kellie Thomson reported on several items including:

- 1. As required by the Book of Order, the 2020 Session Minutes have been reviewed by the Presbytery for *the following churches*: Shepherd of the Hills Casper, Cheyenne 1st, Highlands, Cheyenne Korean, Cody, Encampment, Ft. Laramie, Gillette, Greybull, Guernsey, Jackson, Laramie, Lingle, Moorcroft, Mt. View, Rawlins, Saratoga, Shell, Sheridan, Thermopolis, Torrington.
- 2. *The following churches/NWC* have submitted 2021 insurance policies for review per POW Policies and Procedures 5.01:
 - Shepherd of the Hills Casper, Cheyenne 1st, Highlands, Cheyenne Korean, Cody, Evanston, Ft. Laramie, Greybull, Guernsey, Jackson, Laramie, Lingle, Moorcroft, Pine Ridge, Mt. View, Saratoga, Shell, The Table
- 3. Action Item: Presbytery dismissed, with thanks for their work, the Fremont Administrative Commission

Appreciations Monica thanked Rev. Diana Hartman for her work as Moderator of Presbytery and Rev. Lynn Williamson for her work as Moderator of COM, and presented each of them with a gift.

Installation of Presbytery Moderator and Vice Moderator Ruling Elder Mark Owens was installed as Moderator of Presbytery and Teaching Elder Rev. Steve Niccolls was installed as Vice-Moderator for 2022.
